Why a Trade War?

On April 2nd, The United States (US) had their Liberation Day, which set out to apply a broad-based 10% tariff rate on all imports destined for the US. For certain countries that have a large trade deficit with the US, they had a higher rate based on a ratio of the trade deficit and the country's export to the US. China ended up with a 34% tariff rate that is additive to the already existing 20% tariff rate for an total effective rate of 54% to all inbound Chinese products to the US.

Between Liberation Day and the day of this writing, a series of tit for tat retaliation actions were carried out by both the US and China, which resulted in 145% and 125% respective import tariffs. These rates effectively represent an embargo of trade between the two countries.

One of the narrative of discontent by the US with the current trade situation with China is that China is practicing unfair trade. China is using excessive manufacturing capacity to produce cheap goods that they are unfairly dumping into the US market causing existential harm to US domestic industries. This extra capacity is due to heavy state subsidies, creating an unfair competitive advantage. Therefore, the US must raise a tariff wall to punish the Chinese unfair practice while protecting their local industry. An example of this is the Electric Vehicles (EV's) industry. There are other arguments such as state based current manipulation that artificially lowers the price of the exported product.

Remember in Star Trek, there is a technology call the <u>Replicator</u>. With this technology, as long as there is enough energy, and the design is known, it can produce any product that you want in an instant. Let us take it a step further, and say the technology can harvest energy from thin air as well. A party who possess this Replicator technology can create an environment of abundance. If a country has this and offers this technology to the rest of the world, is it bad for the world? I think most people would say no. At least, on the surface.
